Ms. Montgomery stated 54% of orders for August involved 4 individuals. Central State hospital continues to show success with the decrease of concurrent use of seclusion and restraint.

E. Spit Guard Usage for August 2012 – Presented by Walter Small, Human Rights Advocate Senior OHR.

Mr. Small reported there were two reported usages of the spit guard masks for August 2012. Both usages were done in accordance with hospital policy and procedure.

Ms. Montgomery stated the Department of Behavioral Health decided a few years ago to put together a peer review process in which teams of staff would go into other hospitals and look at various performances. The reasons were to identify areas of vulnerability and to identify the best practices. Central State Hospital is in their second season of these Audits. A team will be auditing the hospital in October 2012. Part of the focus of the audit looks at Human Rights, Abuse and Neglect and Complaints. Ms. Montgomery feels that it's good that the system sees the above mentioned areas as being an important part of the mission to include them in the audit.
